## CIRCULAR

It is proposed to fill up one post of Senior Scientific Officer Gr. I (Forensic Science) (Group 'A' Gazetted, Non – Ministerial) in Pay Level – 11 of the Pay Matrix (pre-revised pay band PB-3 Rs.15600 – 39100/- with Grade Pay Rs.6,600/-) in the Directorate of Forensic Science Services, Ministry of Home Affairs, New Delhi on deputation basis

- 2. The eligibility conditions, experience and job requirements for the post are mentioned in Annexure I enclosed. The maximum age limit for appointment by transfer on deputation shall be not exceeding 56 years as on the closing date for receipt of applications.
- 3. The pay of officers, selected for appointment on deputation, and various other conditions will be governed in accordance with the orders/ instructions issued in this regard from time to time by the Government of India.
- 4. Any officer, who has not completed, in his parent department, a mandatory cooling off period of three years after returning from the last ex cadre service, will be treated as ineligible for being considered for appointment to the post under reference.
